Overall thesis assessment and questions for the defence: (Both the Master's thesis supervisor and reviewer present their questions.)

The aim of this master thesis is to analyze and improve production process of Company SAAS TEKS INVEST, Ltd. Despite the fact that the company has not used any lean methods before, the thesis topic was quite difficult from the point of view of data acquisition and processing. Student spent several weeks in the company and obtained data personally. He was very responsible and hard-working during his stay and project processing.

Analytical part includes some basic process analysis focused on identifying basic problems and constraints. After that, student analyzed problems more in detail. He used Pareto chart analysis for quality control checking, time snapshot analysis for identifying wastes and he also calculated production loss due to machine stoppage at the end.

In the project part, student proposed a lot of improvements divided into several steps. Some of them are described in detail, some of them could have been processed in form of some standards. However, all proposed improvements are useful and their impact to production process productivity is evident.

Formal layout is quite good, just with some small shortcomings, for example: two-line captions are not centered into block, using different styles of tables etc. However, from page no. 80, there is no headline with the name of faculty, university and number of page.

## Questions for the defence:

- 1. How did employees of the company react on your snapshot analysis? Did they cooperate with you without any problems?
- 2. Which of your proposed solutions were/will be implemented and which of them is the most beneficial for the company (according to your opinion)?
